The Outdoor Adventure Education Philippines (OAEPil), in partnership with the IM Innovative Book Publishing House and the International Federation of Physical Education, Fitness, and Sports Science Association, will be having its **OutdoorCon 2023** with the theme **"Trends, Issues, and Best Practices in Outdoor and Adventure Education in the Philippines"** on **February 12, 18, and 19, 2023**, at the Tatlong Bato Campsite, Tanay Rizal. OAEPil is a non-profit and non-stock advocacy group that aims to promote outdoor adventure education and the principles of experiential learning in the natural setting in the Philippines. This Training Workshop/Conference has a minimal registration fee amounting of PHP 2500 and will be charged to each participant and it will take place outside of teaching and working hours, as per D.O. no. 9 s. 2005. **This conference/workshop includes a certificate of completion and attendance, a certificate of recognition for the research presenter, a certificate of completion for the Basic Mountaineering Course (BMC), a camping fee for two days, hosted meals, and the PATHFit 4: Outdoor and Adventure Activities Book.**
