

The Department of Education (DepEd), through the Bureau of Alternative Education (BAE), conducted the Writeshop on the Development of Alternative Learning System (ALS) Assessment Framework from October 11 to 15, 2022 in Filipiniana Hotel, Calapan City participated by select DepEd Officials and DepEd ALS Implementers.

As a next step, the BAE will conduct a Writeshop on the Revision and Finalization of ALS Assessment Framework from February 14 to 18, 2023 in General Santos City, Region XII (specific venue will be announced in separate issuance). This activity, which aims to revise and finalize the ALS Assessment Framework, will involve the same participants of the previous activity. Please see Attachment 1 for the list of participants.

The first meal to be served will be AM Snack on February 14, 2023, while the last meal will be breakfast on February 18, 2023.

Regional ALS Focal Persons are advised to facilitate the most convenient means on the reimbursement of expenses of the participants for this activity. **Downloading of funds to the respective Schools Divisions of the participants is highly encouraged**, when deemed necessary and applicable. In case the downloaded funds are not sufficient to cover the actual expenses incurred, **Program Support Fund (PSF) FY 2022 or local funds** will be utilized to augment the reimbursement of the said expenses.
