REQUEST FOR THE FILLING UP STATUS ON THE

DEPLOYED ADMINISTRATIVE OFFICER II (AO II) ITEMS

FOR FISCAL YEARS (FYs) 2020-2022

The Department of Education (DepEd) has been creating and deploying Administrative Officer II (AO II) items in public elementary and secondary schools. This initiative aims to unload teachers from ancillary and/or non-teaching tasks for them to focus on quality instruction. This is in pursuit of the Department's reform agenda under *Sulong Edukalidad* to pivot its focus on quality education through the provision of adequate support in all public schools.

Per Government Manpower Information System (GMIS) data as of July 2022, a total of **1,821** AO II items from FYs 2020-2021 remain unfilled with FY 2021 having the lowest utilization rate. In effect, DepEd is still far from achieving a 100% hiring rate. Given that the utilization rate affects the decision of the Department of Budget and Management (DBM) over DepEd's annual proposal for additional items, it is imperative to increase the filling-up rate for AO II item. In the absence of the latest GMIS data, the filling up rate for FY 2022 AO II deployment cannot be generated. The latest reports can be found in the attached Annexes.

With this, the **Schools Division Offices (SDOs)** that have not yet achieved the 100% filling-up rate are requested to submit an updated report to the **Regional Office** – **Personnel Section (RO-PS)** concerning the filling-up of AO II items for FYs 2020 – 2022. The RO-PS will submit to BHROD-SED the consolidated report **on or before February 03, 2023** through email address: support.nspp@deped.gov.ph.
