

## Dear Sir/Madam:

Section 3 © of RA 9184, and its 2016 Revised IRR mandate that all procurement shall be governed by the principle, among others, of having streamlined procurement process that will uniformly apply to all government procurement and shall be simple and made adaptable to advances in modern technology in order to achieve and ensure efficient and effective methods. Section 8.1.1. of the same IRR provides that the PHILGEPS shall serve as the primary and definitive source of information on government procurement, and provides that PHILGEPS will continue its modernized efforts to expand its functionalities so that Government may have a fully electronic government procurement system with full functionalities at each stage. This will be realized through the Modernized PhilGEPS, which as of this time, is still on pilot implementation and that full implementation is expected this year.

**EBLSI** currently provides *tried and tested solutions* for online training on the use of PHILGEPS having successfully launched the conduct of full online classes in time of COVID, using available online platforms that mirror the usual 2-days sessions conducted face-to-face, facilitated and anchored by Certified PHILGEPS Trainers from different entities nationwide, using **Zoom** complemented by the PHILGEPS Learning Management System for tutorial guidance and system use.
