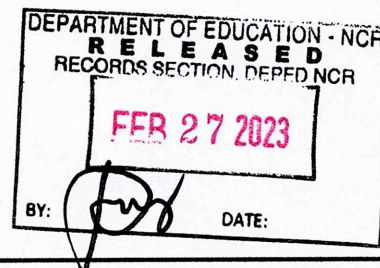

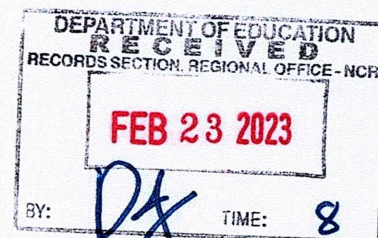

The Department of Education, through the Bureau of Curriculum Development, in coordination with Confucius Institute at Angeles University Foundation (CI-AUF), the program partner for Special Program in Foreign Language-Chinese Mandarin (SPFL-Chinese Mandarin), aims to further explore the opportunities and challenges faced in teaching Chinese as a foreign language and contribute to the enhancement of teachers' pedagogical skills.

Given this, the CI-AUF identified teachers taking Master of Arts in Education major in Chinese Language Education, specified in **Annex A**, to take the **Hanyu Shuiping Kaoshi (HSK) Examination for SPFL Chinese Mandarin Teachers**, an international standardized test that aims to assess the Chinese Language proficiency of non-native speakers, on **March 18, 2023, Saturday**, at **Angeles University Foundation, Angeles City, Pampanga**. The identified teachers are part of the first batch of scholars for the SPFL-Chinese Mandarin.

The test fee will be shouldered by the CI-AUF. The travel expenses shall be charged against the School Maintenance and Other Operating Expenses, Special Education Fund, and/or other local funds of the examinee's station subject to usual accounting and auditing procedures.
