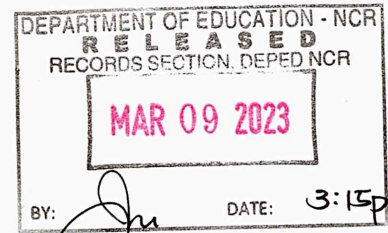

Subject: REINFORCING READING ENGAGEMENT AND EVALUATION FOR ACCELERATING PROGRESS OF SCHOOLS/STUDENTS (REAPS) (Grades 1-3)

Date : March 8, 2023

1. The Curriculum and Learning Management Division (CLMD) will conduct the Reinforcing Reading Engagement and Evaluation for Accelerating Progress of Schools/Students (REAPS) to be held on **March 20-24, 2023** at the **National Academy Educators of the Philippines (NEAP-NCR)**, 15 Cepeda St. Concepcion Marikina City.
2. The objectives of this seminar-workshop are the following:
 - a. produce a compendium of reading selection passages for Grades 1-3 in English and Filipino and
