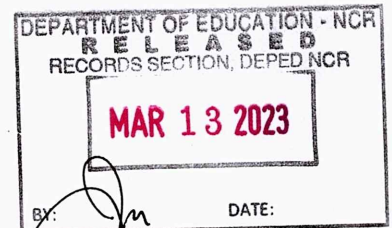

Consistent with Section 5.2 of **DepEd Order No. 55, s. 2016** entitled “**Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program,**” the Bureau of Education Assessment (BEA) with the assistance of regional division and school personnel shall administer the Philippine Educational Placement Test on the third (Luzon cluster) and fourth (Visayas and Mindanao cluster) Sundays of November at designated testing centers.

Relative to this, the Department is pleased to announce that the **Fifty Pesos (Php50.00)** non-refundable registration fee that each application/registrant must pay pursuant to **DECS Order No. 100, s. 1992** otherwise known as “**Revised Rates of Fees and Charges,**” is waived.

Corollary, a new Registration Form for the Regular PEPT administration shall be provided and distributed to field offices.
