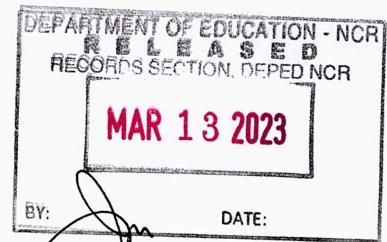

This has reference to the Memorandum dated November 29, 2022 by Atty. Revsee A. Escobedo, Undersecretary for Operations requesting the submission of an incident report on the alleged psychological abuse committed against a learner in Damong Maliit Elementary School, Quezon City.

In the said Memorandum, the Office of the Undersecretary for Operations requested the submission of the incident report as well as the intervention mechanisms imposed to assist the victim-learner. On January 26, 2023, this Office sent a follow-up email regarding the same request, which was not acknowledged up to date. On February 01, 2023 this Office received an email from the Schools Division of Quezon City forwarding the incident report by Ailen Leneth R. Dantes, Master Teacher I, OIC, Office of the Principal of Damong Maliit Elementary School, addressed to Dr. Jenilyn Rose B. Corpuz, Schools Division Superintendent of Quezon City. Based on the latest email received last February 16, 2023, an order to conduct a Fact-Finding investigation on the case was commenced.

In view of the gravity of the offense, this Office request assistance in conducting a virtual meeting with the Regional Child Protection focal persons, Members of the Child Protection Committee, the School Head, and the Guidance Counselor of the Damong Maliit Elementary School. The Regional Office and the School Head may invite other concerned personnel as they may deem needed, to discuss the immediate action taken by the school and the intervention plan in place for the learner concerned. The meeting details are as follows:
