

REQUEST TO SUBMIT FINANCIAL ACCOUNTABILITY REPORT

(FAR) Nos.1 AND 1-A AS OF FEBRUARY 2023

The Department of Education (DepEd) received a letter from the Committee on Appropriations (see attached Annex A), requesting the submission of certain consolidated reports by April 14, 2023. These reports are crucial for the Committee's oversight meeting to determine the DepEd's compliance with the provisions of the General Appropriations Act (GAA). The requested reports are as follows:

- 1. FAR No. 1 Statement of Appropriations, Allotments, Obligations, Disbursements, and Balances (SAAODB) for FY 2022
- 2. FAR No. 1-A Summary of Appropriations, Allotments, Obligations, Disbursements, and Balances by Object of expenditures (SAAODBOE) for FY 2022
- 3. FAR No. 1 Statement of Appropriations, Allotments, Obligations, Disbursements, and Balances (SAAODB) as of February 2023
- FAR No. 1-A Summary of Appropriations, Allotments, Obligations, Disbursements, and Balances by Object of expenditures (SAAODBOE) as of February 2023

It is understood that these reports fall outside the usual reporting period and may not be readily available. However, due to time constraints, a strategy must be devised to meet the deadline. Thus, the CO-Budget Division requests the submission of the **Consolidated Temptable** (excel file) **as of February 28, 2023**, as generated from the Budget Monitoring System (BMS) until March 31, 2023. This will provide sufficient time for processing, clean-up, and consolidation of the temptable's raw data, as well as translation to the FAR 1 and 1-A templates.

The importance of real-time encoding of transactions to the BMS is also emphasized, as this will improve system efficiency, particularly during periods when special reports are required.

Please send the requested BMS temptable to <u>fs.bd.@deped.gov.ph</u>, with a copy furnished to your CO-Budget Division counterpart, on or before **March 31, 2023**.
