This is to respectfully endorse the attached complaint received by the Learners TeleSafe Contact Center Helpline in relation to the alleged sexual and verbal abuse against Mr. Eugene Alicante at Highway Hills Integrated School, Mandaluyong City.

The complainant alleged that Mr. Alicarte, a science teacher, sexually tells explicit jokes to female learners, implying the intent of rape threats. During explosive outbursts, he allegedly often curses and threatens the students. Further, the teacher allegedly engages in unprofessional conduct by sleeping and sharing inappropriate stories during class hours. Since he occupies a prominent position at the school, he allegedly intimidates students into believing that filing a complaint against him is futile.

In line thereto, through LRPO, this Office requests the assistance of the Regional and Division Office having jurisdiction over our teaching personnel under DepEd Order (D.O.) No. 88, s. 2010<sup>1</sup>, to check on the veracity of the allegations.

In view of the gravity of the allegations made, this Office requests the submission of an Incident Report including the intervention mechanisms of the school within five (5) days from receipt hereof. In accordance with the provisions of Republic Act No. 11032 may we request for a timely response within 7 days from receipt hereof in compliance with the abovementioned law as failure to observe the prescribed processing time is a ground for administrative sanctions.
