In support of the MATATAG agenda of Vice President of the Republic of the Philippines and Secretary of the Department of Education (DepEd) Sara Z. Duterte to "take good care of learners by promoting learner well-being, inclusive education, and a positive learning environment," DepEd, through the Bureau of Learning Delivery-Student Inclusion Division (BLD-SID), shall be conducting a series of workshops on the Development, Validation, and Finalization of the Policy on Individualized Education Plan (IEP) for Learners with Disabilities (LWDs).
