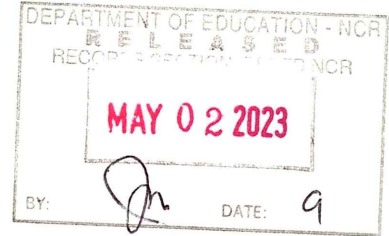

The **Teachers Dignity Coalition (TDC)** will hold the **National Consultation-Training for Teachers** on April 29 – May 1, 2023 at the Benitez Hall, Baguio Teachers Camp, Baguio City.
