

SUBJECT: Learning Assurance for Monitoring and Progress (LAMP)

Year 3 Exit Assessment: Pilot Testing

DATE : May 2,2023

- 1. This is in reference to the Regional Memorandum No.781, s. 2022 entitled Strengthening Assessment Process and Practices of DepEd -NCR Core Assessment Team, relative to the conduct of the above captioned activity on May 15-19,2023 via DepEd National Education Portal (NEP).
- 2. The LAMP Year 3 Year End Exit Assessment pilot testing will be given to the following learning areas:
  - a. for Grade 3, 6 and 10: Science, Araling Panlipunan (AP), Mathematics, English, Filipino and Edukasyon sa Pagpapakatao (EsP)
  - b. for Grade 12: Science, Understanding Culture, Society and Politics (UCSP), Mathematics, Oral Communication, Komunikasyon at Pananaliksik sa Wika at Kulturang Filipino and Introduction to Philosophy of Human Person.
- 3. Test takers for the pilot testing of LAMP Year 3 items must be selected based on the following:
  - **Grade level.** Test-takers who will participate in the pilot testing must be coming from the same level as the target grade level.
  - Learning Area Assignment. Each test-taker must take tests from only two (2) learning areas to avoid fatigue which may affect their performance on the test. The following are the pairing of subjects:
    - for Grade 3, 6 and 10: Science & EsP, Math & English, and Filipino & AP
    - for Grade 12: Science\* & Introduction to Philosophy of Human Person, Math\*\* & Oral Communication, and Komunikasyon at Pananaliksik & UCSP
      - \*Science covers Earth Science for STEM learners and Earth & Life Science for non-STEM
      - \*\*Mathematics cover General Mathematics and Statistics & Probability

- **Number of Test-takers**. A total of 7,290 test takers will participate in the pilot testing. Refer to Enclosure No. 1 for the distribution of the number of test takers per grade level, group (learning area), set of tests, and school typology in each SDO.
- Sampling. Test-takers must be coming from varied school-size typologies -- small, medium, and large schools. The SDO through the Division Testing Coordinator in coordination with the DITO will identify the schools to be included that belong to these typologies to be validated by the SGOD Chief. Also, test-takers will be randomly selected to partake in the pilot testing.
- 4. Learners included in the pilot testing shall be reminded of their LRN, DepEd Email /Office 365 account and oriented on the features of the National Education Portal.
- 5. The Division Testing Coordinator will prepare the list of test takers for the pilot testing using the template which can be accessed through this link https://bit.ly/3LiEWl3. Likewise, it will be submitted to the Regional Testing Coordinator on or before May 8, 2023, through this link https://bit.ly/3nfW56P.
- 6. Division Information Technology Officer (DITO) shall oversee the enrollment of learners in the NEP. The school ICT Coordinator shall enroll the test takers in the NEP starting at 12:01am on May 9 up to 11:59pm of May 12, 2023.
- 7. The pilot testing will be conducted in the school computer laboratory to be facilitated by the school testing coordinator and school ICT coordinator. The division testing coordinator will oversee the conduct of the pilot testing. Regional monitoring teams are advised to coordinate with the DTC for the smooth conduct of the pilot testing.
- 8. Refer to Enclosures No. 2-5 for the Terms of Reference, timelines, Test Administration Proper and Composition of Monitoring Team.
- 9. Expenses relative to the conduct of this activity shall be charged to local funds subject to usual accounting and auditing rules and regulations.

10. Immediate and wide dissemination of this Memorandum is desired.
