

This has reference to the attached complaint received to the Learner Rights and Protection Office-Learners TeleSafe Contact Center Helpline (LRPO-LTCCH), relative to the alleged dismissal of a student committed by the School Head and adviser of a learner in Parañaque National High School, Parañaque.

The report revealed that the above-mentioned school dismissed a learner due to absenteeism, despite presenting a valid medical certificate. According to Department Order 52 s. 2012 or "The New Organizational Structures of the Central, Regional, and Schools Division Office of the Department of Education" the Regional Office is responsible for ensuring access to, promoting equity in, and continuously improving the quality of basic education in the region and schools division under his or her supervision.

This matter is being referred to that Office considering that the subject of inquiry falls under its jurisdiction and may best be addressed by that Office.
