This has reference to the mandates of Republic Act No. 11313 or "An Act Defining Gender-Based Sexual Harassment in Streets, Public Places, Online, Workplaces, and Educational or Training Institutions, Providing Protective Measures and Prescribing Penalties Therefor" otherwise known as the "Safe Spaces Act," (SSA) signed into law last April 17, 2019, directing all schools to enact an anti-sexual harassment policy that will protect students and teachers in all forms of sexual harassment.

In compliance thereof, the Learner Rights and Protection Office (LRPO) shall conduct an Orientation on the Safe Space Act and on Sexual Orientation, Gender Identity, Gender Expression, and Sex Characteristics preparatory in the drafting of the guidelines and DepEd Order on **May 9-10, 2023,** from 9am to 12nn.

Accordingly, we hope to invite the following technical working group members (TWG)¹ Members as implementers, writers, and resource persons to this Orientation, the same individuals were invited during the writeshop on the "Enhancement of the DepEd Child Protection Policy" last March 27-30, 2023.
