

As the country is geared towards Universal Health Care (UHC), an integrated approach in the implementation of health policies and programs remains the key for its progressive realization through a whole-of-society and a whole-of-nation approach. The Department of Health - Metro Manila Center for Health Development (DOH-MMCHD) in partnership with PhilHealth is constantly enabling residents of the National Capital Region to have better access to health care services and experience a more responsive health system that protects them from financial hardship.

The Accreditation of primary care providers for Philhealth Konsultasyong Sulit at Tama (Konsulta) Package or PHIC Circular 2020-021 will address the financial hardships of our constituents for this will provide capitation to be included in the Special Health Fund of the LGUs. This will enable access to primary care by adopting a responsive financing mechanism for the delivery of quality primary care services and commodities provided they are **registered** to their Primary Care Provider Network of choice as expressed in DOH-PHIC JAO 2020-001 "Guidelines on the Registration of Filipinos to a Primary Care Provider."

In view of this, we are respectfully requesting the Division of City Schools to direct all Local School Boards in their jurisdiction to collaborate with their respective City/Municipal Health Officers, DepEd and School Superintendents for an orientation on **Konsulta Program**, **Registration** and **First Patient Encounter to Konsulta**. Attached is the list of PhilHealth contact persons deployed in the LGUs for easier coordination pertaining to this initiative and fast track the registration of all Juan and Juanas of NCR to its respective primary care provider.
