The NNC is inviting participants to its e-Learning Course on Local Nutrition Program Management (eNPM) open to all nutrition action officers, district/city/municipal nutrition program coordinators, nutrition staff, members of provincial, city and municipal nutrition committees, and other nutrition stakeholders.

The eNPM aims to provide competencies on effective planning, implementation, monitoring and evaluation of nutrition programs in the context of the overall local governance and development system. As an e-learning course, it provides an alternative mode for learning and improving competencies of those who are involved in local nutrition program management by enabling learners to access the course on their preferred schedules and at their own pace. Participants who successfully complete the course will receive certificates of completion. The course has also been applied as a CPD Accredited Program of the Professional Regulation Commission (PRC) under the profession of Nutritionist-Dietitians, Medicine, Nursing, Midwifery, and Social Workers to provide CPD credit units (subject to approval) to licensed professionals who successfully complete the course.

- Batch 1: 25 May to 20 July 2023
