The Commission on Higher Education National Capital Region is pleased to announce that the call for applications to the CHED Merit Scholarship Programs (CMSP) with 846 new slots for NCR, Academic Year (AY) 2023-2024, is NOW OPEN.

The deadline of application is on May 31, 2023. Applications must be submitted ONLY through our Online Application Link - <https://csp-application.chedro-ncr.com>. WALK-IN application will not be entertained.

The CMSP is offered to incoming first year college students for AY 2023-2024 who will take up any of the identified priority programs listed in <https://csp-application.chedro-ncr.com/application/index.htm> in CHED recognized higher education institution. Eligibility requirements are as follows:

1. Filipino Citizen;
2. Graduating high school student/High school graduate with general weighted average (GWA) of at least 93%;
3. Combined ANNUAL GROSS INCOME of parent/s, guardian which **DOES NOT EXCEED** four hundred thousand pesos (Php400,000.00) or in cases where the income exceeds Php400,000.00, with family member with medical illness or with two or more dependents enrolled in college

In view of this, we are requesting for your assistance in disseminating this call for application to prospective student-applicants.

Student applicants who fulfill the requirements shall be ranked and selected based on the above eligibility and other documentary requirements stipulated in CHED Memorandum Order (CMO) No. 8, series of 2019 and CMO Order No. 11, series of 2021; and availability of slots/funds.
