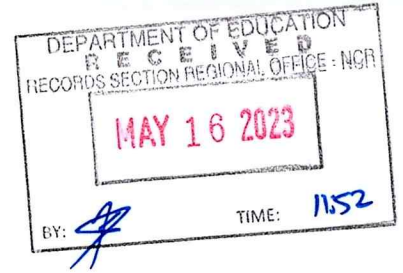

**Dear Dr. Cabral,**

We received your letter dated April 25, 2023, which was received by Cambridge Children's Learning and Development Inc. (CCLDI or Cambridge Preschool) on May 5, 2023, with regards to our request for reconsideration on the retention of our government recognition status for our institution that has been transferred to its new location at 2nd Floor Serendra, 11th Ave., BGC, Taguig City. We appreciate your prompt response to our request, and we would like to take this opportunity to address the concerns raised in your letter.

Firstly, we understand that government recognition issued by your office to our institution is non-transferable as provided under Section 37 of DepEd Order No. 88, s. 2010 on transfer to another location. However, we would like to emphasize that we have complied with the exception provided by DepEd for retaining government recognition status upon transfer to another location. Our new site and campus buildings are much better than our former location, and we have maintained and exceeded all other standards set by the DepEd.

Secondly, we would like to emphasize that our new location at Serendra is closer to our student base. It provides a larger school area with better ventilation, and it is much more convenient for our students, who no longer need to take a car to reach our institution. This is a crucial factor in ensuring that our students continue to receive quality education safely.

Finally, we would like to reiterate the unprecedented impact of COVID-19 on the education sector. Many schools had to close down due to the pandemic, and our institution has remained steadfast in our commitment to provide education to our youth. We have complied with all the requirements stipulated in DepEd Order No. 88, s. 2010, and we have undergone the necessary evaluation and inspections to ensure that we meet all the standards set by the DepEd.

In light of these circumstances, we respectfully request that you reconsider our request to retain our government recognition status. We believe that we have complied with the exception mentioned by the DepEd, and we have gone above and beyond to ensure that our institution meets all the necessary standards.

Thank you for your time and attention to this matter. We look forward to a favorable response from your office.

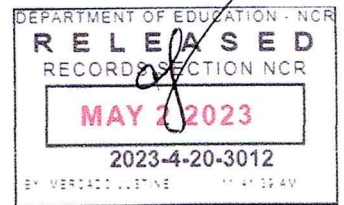

This refers to your letter received by this Office on April 15, 2023, relative to your request for reconsideration. In your letter, you stated that you would like to carry the Government Recognition status (Government Recognition No. P-038, s, 2010) as your institution will be transferred to its new location with the updated 15-year lease contract.

A government recognition issued by this Office to your institution is non-transferable as provided under **Section 37 of DepEd 88 s., 2010 on Transfer to Another Location**, and a government-recognized school that transferred to another location is deemed cancelled, however, government recognition may be retained as an exception if the new site and campus buildings and quarters are found to be much better than the former, and if all other standards have been satisfactorily maintained. Further, retention of the cited government recognition is still subject to regular conduct of evaluation by this Office.

As such, we regret to inform you that your request **cannot be given due course and is hereby disapproved**. Please be advised that for this Office to approve your application, **ALL the requirements stipulated in DepEd Order 88 s., 2010 otherwise known as "2010 Revised Manual of Regulations for Private Schools in Basic Education"** must be complied with.
