

MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Understanding ("Memorandum") is made and entered into by and among:

THE DEPARTMENT OF EDUCATION of the Republic of the Philippines, through its Regional Office at the National Capital Region, with offices at the DepEd-NCR Complex, Misamis St., Bago Bantay, Quezon City represented herein by its Regional Director WILFREDO E. CABRAL, hereinafter referred to as "DepEd-NCR";

-and-

GREATFIL TEAM, INC., a domestic corporation duly organized and existing under and by virtue of Philippine laws, with office address at Brixton Hill Condominium, 552 T. Arguelles St., Sta. Mesa, Manila, represented in this Act by its President, MR. PATRICIO GOC-ONG, hereinafter referred to "Greatfil";

-and-

NESTLÉ PHILIPPINES, INC., a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with administrative offices at the Nestlé Center, 31 Plaza Drive, Rockwell Center, Makati City, represented in this Act by its Senior Vice President and Head of Corporate Affairs, MR. JOSE T. UY, III, hereinafter referred to as "NPI";

RECITALS

WHEREAS, the DepEd-NCR is the lead government agency that formulates, implements, and coordinates policies, plans, programs and projects in the areas of formal and non-formal basic education and supervises all elementary and secondary education institutions under its jurisdiction;;

WHEREAS, NPI, through its Corporate Affairs Department, will provide a school-based wellness program entitled the "SY 2023-2024 Nestlé Wellness Campus" (the "Project" or the "Program") which shall be organized and implemented through and with the assistance of GTI;

WHEREAS, NPI, through its partner research agency, seeks to collaborate with DepEd-NCR in conducting a research on the knowledge, attitudes, behavioral intention, and practices of healthy habits among Filipino learners, thereby contributing empirical data to the growing health and nutrition issues of Filipino children;

WHEREAS, DepEd-NCR, NPI and GTI desire to collaborate for the successful implementation of the Project in all DepEd-NCR Junior High Schools, Senior High Schools and Public Elementary Schools located in the National Capital Region from 1 May 2023 to 30 April 2024;

NOW, THEREFORE, the Parties hereby set out the terms and conditions under which this partnership will be governed.

- 1. NPI, with the assistance of GTI, has established and intends to implement the Project, a program that aims to educate public high school and elementary students located in the National Capital Region on nutrition, health and wellness to establish healthier eating, drinking and lifestyle habits. The Project shall be organized and conducted pursuant to the Program mechanics attached hereto as Annex "A".
- 2. NPI shall have the following obligations:
 - 2.1. NPI will provide nutrition, solid waste management, and physical education modules for all public elementary and junior high schools including modules on entrepreneurship and employability for senior high schools in the region.
 - 2.2. In close coordination with DepEd-NCR, to conduct a cross-sectional, descriptive study on the knowledge, attitudes, behavioral intention and practices of healthy habits among Filipino learners through its partner research agency.
 - 2.3. To present a report on the aggregate findings of the research conducted by NPI's partner research agency
 - 2.4. Through GTI, conduct regional and division cascades of the mechanics and details of the Program to the DepEd-NCR Regional Representatives and Division Supervisors duly assigned to handle the program and cascade the mechanics and implementation plan per division or district to the MAPEH and/or PE School coordinators and principals.
 - 2.5. Create, produce, and timely provide the following materials required for the Project:
 - a. Nestlé Wellness Campus modules, particularly Nutrition, solid waste management, physical education modules for the students in both public elementary and high school level including modules on entrepreneurship and employability for senior high school in the region.
 - b. Nutrition modules for parents
 - c. Dancercise music
 - 2.6. To provide timely and effective media amplification for the Project on print, TV and digital (web and/or internet-based) media.
 - 2.7. Through GTI, invite public school teachers and parents to join the Nestlé Wellness Campus Facebook communities.
 - 2.8. Organize and manage the inter-school contest and other wellness-related events like webinars, cooking demos and Nestlé-sponsored activities.

- 2.9. Coordinate with GTI and the DepEd-NCR for the orderly implementation of the Project
- 2.10. Together with GTI, conduct meeting alignment and updates pertaining to the Program with DepEd-NCR stakeholders
- 3. The DepEd-NCR shall have the following obligations:
 - 3.1. Through the DepEd-NCR Regional Director:
 - a. Endorse the Project to all Division Superintendents within the region;
 - b. Provide guidance and technical advice to ensure proper implementation of the Project
 - c. Suggest and recommend on the progress of the Project moving forward based on final results provided that all obligations of the other parties had been fully carried out.
 - 3.2. Through the Education Support Services Department (ESSD) Chief
 - a. Coordinate with GTI and DepEd-NCR Division Supervisors duly designated for the program implementation
 - b. Facilitate the issuance of the endorsement letter to all DepEd-NCR Division Supervisors of and to all Superintendents in the region
 - c. Assist GTI in monitoring Project execution in the region
 - d. Provide recommendations on how to improve the Project moving forward.
 - e. Monitor the implementation of the program in the Region
 - f. Organize the regional cascade together with GTI
 - 3.3. Through the Policy, Planning, and Research Division (PPRD) Chief:
 - a. Coordinate with GTI and DepEd-NCR Division Supervisors/Senior Education Program Specialists (SEPSs) on the conduct of the research related to Clause 2.2 above and Clause 3.3 (b) below.
 - b. Identify the schools to be included in the sampling frame
 - Facilitate the issuance of an endorsement letter to Division Superintendents,
 Division Supervisors and School Principals of the schools involved in the research
 - d. Provide recommendations based on the provided Project Report drawn from the results of the study
 - 3.4. Through the duly designated DepEd-NCR Division Supervisor:
 - a. Coordinate with GTI and the PDO IV or ESSD Chief or PPRD Chief in the program implementation
 - b. Attend the regional program cascade conducted by GTI and ESSD Chief
 - c. Receive and facilitate the distribution of different materials provided by NPI through GTI for his/her division
 - d. Assist GTI in monitoring the program execution, ensuring that all the schools in his/her division will receive the materials
 - Assist GTI and DepEd-NCR Regional Officials during video and photo coverage, and media interviews that will be conducted by NPI representatives or partner agency


