In the Philippines, Neglected Tropical Diseases (NTDs) includes leprosy, rabies, soil-transmitted helminthiasis, and food and waterborne diseases that threaten the health and, consequently, the livelihood of Filipinos. These diseases are "neglected" because those afflicted with NTDs remain hidden, thus responses and resources don't receive equal attention. Integration of strategies targeting several NTDs and multisectoral, multidisciplinary approach requiring strong, viable and sustainable partnership involving various agencies of the government, such as the academe. Effective promotion on the prevention and referral of such diseases in schools not only safeguards the health of the students and staff by minimizing the harm caused by the diseases, but also ensures a delightful learning environment to support the healthy development of students.

With this, the Department of Health - Metro Manila Center for Health Development (DOH-MMCHD) through the Infectious Disease Prevention Control Cluster (IDPCC) will conduct Neglected Tropical Diseases Program Updates for School Division Officers in the NCR on July 4, 2023 from 8:00 AM- 5:00 PM at Manila Grand Opera Hotel, Santa Cruz, Manila.
