1. This has reference to the attached Memorandum OUOPS No. 2023-07-4251 from **ATTY. REVSEE A. ESCOBEDO**, Undersecretary For Operations, and **ANNALYN M. SEVILLA**, Undersecretary for Finance, DepEd Central Office, dated May 9, 2023, re: guidelines on the release, use, reporting, and monitoring and evaluation of program support funds (PSF) for the conduct of consultation conferences for the enhancement of DepEd Order No. 40, s. 2012, otherwise known as the "DepEd Child Protection Policy."

  - c. Madrasah program learners
  - d. Children in street situations (CiSS)
  - e. Child-at-risk (CAR)
  - f. Children in conflict with the law (CICL) under an aftercare program
  - g. Learners with special needs (SPED)
  - h. Boy/Girl Scouts
  - i. LGBTQ+
