The testing window for the Administration of the National Learning Camp Assessment for Grades 7 and 8 Learners for School Year 2022-2023 is extended from July 7 to July 14, 2023. The test administration started on June 21, 2023, as per memorandum DM-CT-2023-166 dated June 20, 2023, through the Bureau of Education Assessment-Education Assessment Division (BEA-EAD) in coordination with the Information and Communications Technology Service (ICTS) and Bureau of Learning Delivery (BLD).

The testing window extension intends to offset the backlogs in the testing days due to the system maintenance and upgrade of the Regional Moodle Learning Management System (LMS) last **June 27 to 28, 2023**, resulting in the inaccessibility of the Regional Moodle LMS.

On the other hand, the Regional Testing Coordinators (RTCs), with the assistance of the Division Testing Coordinators (DTCs) are requested to submit a consolidated list of non-participating schools in the NLCA and their corresponding valid reasons.
