Subject : **Agreements on the National Learning Camp (NLC)**

Date : **July 12, 2023**

As per the Joint Regional Executive Committee and Management Committee Meeting held today, July 12, 2023 at Varela Hall of DepEd-NCR, this Office reiterates the following agreements on the National Learning Camp (NLC):

1. Regional Office (RO) will spearhead the printing of Grades 2, 3, 7 and 8 teaching and learning materials. Upon printing, these materials shall be delivered in the Schools Division Offices (SDOs) wherein they will ensure that it will reach the schools on time for the implementation of NLC on July 24;
2. Other funds that will be downloaded by RO to SDOs:
 - Board and lodging, materials and travel expenses for the Capacity Building of Grades 7 and 8 teacher-volunteers (8,980/pax)
 - Budget for meal expense of Grades 1 to 12 teacher-volunteers (250/day/pax)
 - Reimbursement of travel expenses incurred by English, Science and Mathematics Chief trainers who attended the national training last June 28 to 30 in Baguio City (3,760/pax)
 - Allocation for advocacy materials (1,000/school)
 - Delivery cost from SDO to schools of Grades 7 and 8 materials (2/learner)
 - Budget for procurement of 8GB USB for Grades 2 and 3 teacher-volunteers in Reading Program (300/teacher-volunteer)
 - Reproduction cost of teaching and learning materials for learners undergoing Remediation in other grade levels (Grades 1 to 12) and other learning areas (60.80/learner);
3. Note that items 1 and 2 requires data on the numbers of learners and teachers at your end encoded in the Google sheet: www.bit.ly/ncrnclschools, hence, please take note of the following deadlines:
 - Grades 7 and 8 data: 5:00 pm, July 12, 2023
 - Grades 2 and 3 data: 5:00 pm, July 13, 2023
 - Grade 1 Tara,Basa! And Remediation data: 5:00 pm, July 14, 2023
 - Registration and parental consent forms uploaded in the school's Google drive: Monday, July 17, 2023
