Date : August 8, 2023

- 1. The Department of Education- National Capital Region through the Curriculum and Learning Management Division will conduct the above-captioned activity on August 19-20, 2023. This is a live-in activity in a venue to be announced.
- 2. The activity aims to capacitate the core analysts' team of the region in organizing, finalizing, and interpreting the results of the recently concluded LAMP Year 3 Year-End Assessment.
- 3. Participants are the selected math teachers and supervisors who will be the part core analysts' team of the region in organizing and interpreting assessment results. The participants' requisite knowledge on SOLO Framework, subject specialization, and preparation were the major criteria used for selection, while adhering with the Equal Opportunity Principle (EOP) where age, gender, civil status, religion, ethnicity, or political affiliation did not in any way deter their inclusion in the roster of participants of the said activity.
- 4. Consequently, teachers shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003 entitled *Updated Guidelines on the Grant of Vacation Service Credits to Teachers*. On the other hand, non-teaching including the management staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on *Non-Monetary Remuneration for Overtime Service Rendered*.
