

The Office of the Undersecretary for Operations (OUOPS), through the Office of the Assistant Secretary for Operations (OASOPS) and Bureau of Learner Support Services-Learner Formation Division (BLSS-LFD), transitioning from Youth Formation Division, will spearhead the International Youth Day Celebration 2023 on Saturday, August 12, 2023, from 8:00 a.m. to 4:00 p.m. at Tanghalang Rizal, Pasig City.

In partnership with the External Partnerships Service (EPS), Local Government Unit (LGU) Pasig City, DepEd - National Capital Region (NCR), and Schools Division Office of Pasig City, this activity aims to:

- a. provide a platform to honor the qualities of the youth with diverse backgrounds and unique identities and the potential that they hold towards the development of a nation and the world as a whole;
- b. acknowledge the challenges faced by the learners and the youth and identify possible means and resolutions with the help of the government, private entities, religious sectors, civil society organizations (CSOs), and other stakeholders;
- c. serve as the Filipino learners' interactive engagement opportunity in celebrating the International Youth Day full of fun, learning, and inspiration;
- d. appreciate young people's "puso, galing, at talino" in bridging the gaps and creating opportunities for lifelong and holistic learning and development;
- e. amplify the message that action is needed across all generations to achieve the Sustainable Development Goals (SDGs) and leave no one behind; and
- f. raise awareness on specific barriers to intergenerational solidarity, notably ageism, which impacts young and old persons, while negatively affecting the society.

In this regard, the OASOPS would like to respectfully request approval from your good Office to allow the participation of the following to the aforementioned event:

- 1. Seven (7) elected Division Federation Supreme Secondary Learner Government (DFSSLG) Officers from the sixteen (16) divisions of NCR, accompanied by three (3) chaperones, preferably the Division Youth Formation Coordinator (YFC) / Project Development Officer I or SSLG Teacher-Adviser as an alternate.
- 2. Twenty (20) learner-performers and two (2) teacher-trainers from Nagpayong High School, Pasig City.
- Fifty (50) learners and (10) teachers (to be identified by the Schools Division Office of Pasig City).

Travel and other related expenses to be incurred by all participants involved in the said activity shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.

Moreover, the OASOPS respectfully recommends that all teaching and non-teaching personnel who will participate in the said activity be allowed to avail of service credits and Compensatory Time Off (CTO), subject to DepEd's existing rules and regulations and approval of respective Schools Division Offices (SDOs).

Annex A.

Event Rationale

It is undeniable that in the past years, the youth have proven themselves vital in the country's national development. To propel a nation towards genuine progress in this contemporary age, there is an urgent call to maximize youth participation in all aspects of society. United Nations (UN) Former Secretary-General Kofi Annan encapsulated the idea that young people should be at the forefront of global change and innovation believing that they can be empowered key agents for development and peace.

In 1965, the United Nations General Assembly began making efforts to improve the lives of youths around the world. The Declaration on the Promotion among Youth of the Ideals of Peace, Mutual Respect, and Understanding Between Peoples was approved, and there was an increase in the amount of time and resources given to empowering the youth. The same was done by recognizing emerging leaders and providing them with resources to satisfy the needs of the world.

In 1999, the World Conference of Ministers Responsible for Youth issued another request to mark International Youth Day. The resolution was adopted by the United Nations General Assembly on December 17, 1999, and the first International Youth Day (IYD) was observed on August 12, 2000.

The Philippines, with its rich historical timeline, has had remarkable flickers of student power showcased to the rest of the world. The power of the youth has always been at the pinnacle of the country's strife for freedom even during the time of colonization. With the pandemic limiting mobility and interaction, the Department of Education (DepEd) understands the need to heighten the thrust for youth development and participation. Young people should be provided with a platform that will pave the way for participatory and inclusive engagements promoting the DepEd Core Values and highlighting their skills, talents, perspectives, and sentiments in various discussions.

Thus, the Office of the Assistant Secretary for Operations (OASOPS), through the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD), will conduct the International Youth Day (IYD) Celebration on August 12, 2023, in Pasig City, Philippines.

Observed every August 12 each year, the IYD offers a platform to honor the qualities of youth and the potential that they hold towards the development of a nation and the world as a whole. The day also acknowledges the challenges faced by them and eliminates the issues. A lot of contribution is made by young people towards community development, in protection of environment and volunteering on various social projects. The day calls everyone to join the efforts of United Nation and help it achieve its SDGs.

The Department seeks to gather selected learners, youth leaders, and education stakeholders with diverse backgrounds from different elementary and secondary institutions within Metro Manila and nearby local communities/regions. The said gathering will be done in a face-to-face arrangement that will allow the learner participants the opportunity to learn not only from the key national and international speakers and activities but also learn by engaging with one another, especially understanding different cultures across regions, and widening global perspectives through international exposures and experiences.

With youth and the aged working together, we can create a better and livable world for all!

I understand that the Office of the Assistant Secretary for Operations (OASOPS), through the Bureau of Learner Support Services-Learner Formation Division (BLSS-YFD) of the Department of Education shall implement the minimum public health standards set by the government to minimize the risk of the spread of COVID-19, but it cannot guarantee that my child may not be infected with COVID-19 given that it is highly contagious.

I understand that my child's in-person attendance in the event will include associating with teachers, fellow learners and school personnel, and other persons inside and outside of the school that may put my child at risk of COVID-19 transmission, notwithstanding the precautions undertaken by the implementing team.

Voluntary Participation

I acknowledge that my child's participation in this activity is completely voluntary. My child may decline to participate or withdraw from participation at any time for any reason. Declining or withdrawal of participation will not result in any penalty or loss of benefits or reduction of any basic right to which my child is entitled. While there remains the risk of possible COVID19 transmission to my child/ren, and to the members of my household, I freely assume the said risk and I permit my child/ren to attend this activity.

Exclusion (Limitations/Ineligibility)

I am aware that symptoms of COVID-19 include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, the new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea.

I confirm that my child currently has none of those symptoms and is in good health. I will not allow my child to physically go to the event if my child or any member of my household develops any of the said symptoms or any other symptoms of illness that may or may not be related to COVID-19. I will also inform the school/division and not allow my child to attend the event if my child or any of my household members tests positive for COVID-19. My child/ren and I, with my household members, will follow the required health and safety protocols and procedures adopted by the school and our community.

Documentation

I confirm that I give full permission in any recording or picture taken of my child during the conduct of this event and to use some or all of my child's images/ contribution/ performance in any publication (including electronic publications such as film or website) created by or for

the BLSS-YFD and its program partners and to release this material to the official platforms of the Department.

Confidentiality
