Esobedo, Undersecretary for Operations, Department of Education, pursuant to the Commission on Election Resolution No. 10902, or the "Revised Calendar of Activities and Periods of Certain Prohibited Acts in Connection with October 30, 2023, Synchronized Barangay and Sangguniang Kabataan (SK) Elections," the Election period shall commence from August 28 to November 29, 2023.
- 2. Attention is invited to paragraph no. 2, for the conduct of mall voting in selected areas specifically in NCR, Region V and Region VII.

Likewise, paragraph no. 4, Division Offices having jurisdiction with the specified mall voting areas are requested to participate and issue memoranda relative to the designation of public-school teachers as members of the Election Board and DepEd Supervisor Officials (DESOs). The designated BBOCs for both the actual and simulation election shall undergo training on three (3) consecutive Saturdays in September 2003.
