





#### CONTRACT

# FOR THE PROCUREMENT OF SERVICE VEHICLE - AIRCON PASSENGER VAN FOR DEPED NCR NEAP

KNOW ALL MEN BY THESE PRESENTS:

This Contract is made and entered into by and between:

**DEPARTMENT OF EDUCATION** with office address at Misamis Street, Bago Bantay, Quezon City represented herein by its **Regional Director**, **WILFREDO E. CABRAL**, **CESO III** hereafter referred to as the **Procuring Entity**;

and

TOYOTA ABAD SANTOS with office address at 2210 Jose Abad Santos Ave., Manila, herein represented by its Marketing Professional, JOAN TULIAO hereafter referred to as the Supplier;

The Procuring Entity and the Supplier shall be collectively called "PARTIES"; WITNESSETH:

**WHEREAS**, the **Procuring Entity** authorized the procurement of Service Vehicle - Aircon Passenger Van of DepEd NCR NEAP with an ABC of Php1,724,000.00.

**WHEREAS**, the invitation to bid (ITB) was first posted on the PhilGEPS, Bulletin Board and Website on April 13, 2023. However, no bids were submitted.

**WHEREAS**, the second invitation to bid was posted on May 20, 2023, still no bids were received;

**WHEREAS**, in view of the two failed biddings, the Bids and Awards Committee (BAC) undertook the procurement through Negotiated Procurement pursuant to Section 53.1 of the revised IRR of RA9184;

**WHEREAS**, request for quotation were sent to prospective suppliers/bidders and per evaluation of the BAC, the bid of the **Supplier** (Toyota Abad Santos) has been found and declared as the lowest calculated quotation on the same specifications of the required vehicle for a bid amount of Php1,711,000.00;

**WHEREAS**, on July 20, 2023, the Bids and Award Committee through BAC Resolution No. 28, s. 2023 recommended award of contract to the Supplier;

**WHEREAS**, on July 20, 2023, the Regional Director as Head of the Procuring Entity approved the recommendation of the BAC to award the contract to the **Supplier** and on the same date issued a Notice of Award to the **Supplier**;

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Parties hereby agrees and bind themselves as follows;

#### Article I GENERAL PROVISION

This Contract shall be for the procurement of Service Vehicle - Aircon Passenger Van of DepEd NCR NEAP.

## Article II OBLIGATION OF THE SUPPLIER

- 1. The Supplier shall supply the Service Vehicle Aircon Passenger Van of DepEd NCR NEAP as quoted in compliance with the terms and conditions of this agreement;
- 2. The Supplier shall supply to DepEd NCR NEAP a brand new Service Vehicle Aircon Passenger Van, as quoted, with the approved specifications, to wit:

Engine Type 4 Cylinders

Diesel, In-Line Type 16 Valve DOHC

Fuel Capacity - 70L

Power Transmission - 6 Speed Manual Transmission

Front Break/Rear Brake - Ventilated Discs/ Drum

Tires - 215/70 R16 C

Wheels - 7J x 16

3. The period to supply the Service Vehicle - Aircon Passenger Van is **thirty** (30) days upon receipt of the Notice to Proceed;

### ARTICLE II TERMS OF PAYMENT

- 1. The Procuring Entity shall pay to the Supplier the total amount of One Million Seven Hundred Eleven Thousand Six Hundred Pesos (Php1,711,600.00) as purchase price of the vehicle.
- 2. Payment shall be made after the acceptance of the vehicle by the **Procuring Entity** (DepEd NCR NEAP Representative) and after submission of the **Statement of Billing Account** based on the contract price with all other documentary requirements by the Supplier.

### ARTICLE IV AMENDMENTS

Amendments or modification of any of the terms and conditions of this Agreement shall be valid and binding provided it is evidenced by a subsequent written Supplemental Memorandum of Agreement duly executed and signed by the respective authorized representatives of both parties.

## ARTICLE V MISCELLANEOUS PROVISIONS

- 1. The parties are independent of each other and nothing in this Agreement shall be construed so as to constitute the parties as partners, joint ventures, agents, employees or representatives of the other for any purpose whatsoever.
- 2. If any part if this Agreement is declared unenforceable or void by a court of competent jurisdictions, the rest of the Agreement shall nevertheless remain in full force and effect.
- 3. No failure, omission or delay of any of the parties in exercising any of its rights, privileges and remedies hereunder shall operate as waiver thereof. No waiver or departure from the terms of this Agreement shall be valid and binding unless made in a written Supplemental Memorandum of Agreement and signed by the party's authorized representative.
- 4. It is stipulated and expressly understood that existing laws, rules, regulations in so far as not inconsistent or modified by the contract, shall form part and parcel of this Agreement.
- 5. In case of conflict arising from this Agreement, both parties shall agree to freely and voluntarily submit themselves to proper mediation and Arbitration proceedings pursuant to Presidential Decree No. 242 and other related laws on mediation and arbitration.
