The Legal Service - Investigation Division of the Department of Education (DepEd) will conduct the **Training-Workshop on Investigation and Prosecution Techniques** on **September 25-29, 2023** at Villa Excellance Beach & Wave Pool Resort, Sahud-Ulan, Tanza, Cavite Province.

The training-workshop aims to equip the Legal Officers with the skills and techniques on investigation and prosecution of cases. Topics under DepEd Order No. 49, s. 2006, otherwise known as the "Revised Rules of Procedure of the Department of Education in Administrative Cases" and the 2017 Revised Rules on Administrative Cases in the Civil Service will be discussed; Trial Skills of an Effective Prosecutor will also be tackled specifically on Case Preparation, Identification and Examination of Witnesses, Identification and Admission of Documentary and Object Evidence, Proper Use of Objections and Rebuttal Evidence and Drafting of Joint-Affidavit and Position Paper. Also, in line with the MATATAG Agenda on taking good care of learners, there will be a lecture on Child Protection in relation to presenting and interacting with child witnesses before and during trial. Further, to engage the participants, open forums and simulation exercises will be conducted.


