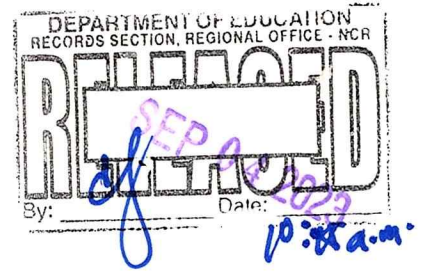

**CHAMPIONING THE LEARNER RIGHTS AND PROTECTION IN  
NATIONAL CAPITAL REGION**

1. The Department of Education – National Capital Region through the Learner Rights and Protection Section (Formerly Child Protection Unit) will hold a training workshop entitled, **“Championing the Learner Rights and Protection in National Capital Region.”**
2. This is in line with the MATATAG Flagship Program of the Vice President and Secretary of Education, particularly the third component: *Take good care of learners by promoting learners’ well-being, inclusive education, and a positive learning environment* on **September 26-28, 2023** to be held at **Varela Hall, Regional Office, Department of Education - National Capital Region.**
3. This 3-day event aims to strengthen mechanisms in safeguarding learners against all forms of abuse including but not limited to physical, emotional, neglect, exploitation, and discrimination or acts which are dismissive and hostile in a manner committed by adults as well as their peers (*DepEd Order No. 40, s. 2012*), and establish LRP case management and develop psychosocial intervention programs for learners’ overall well-being in the National Capital Region.
4. The expected participants are the Division Learner Rights and Protection Focal Persons, and Registered Guidance Counselors from the school who shall register at this link: **<https://tinyurl.com/Championing-LRP>** on or before **September 18, 2023.**
