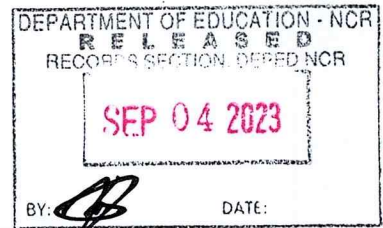

The Department of Education-National Capital Region in its continuous thrust to reinforce foundational skills in literacy and numeracy and support teachers and learners with technology to maximize the benefits of digital and remote learning, has partnered with Khan Academy to pilot their "Filipinized" course content for Grade 4 learners in the following schools:

Relative to this, teachers, mathematics department heads and/or school heads of the implementing schools shall attend a training on September 2, 2023 at Mataas na Paaralang Neptali A. Gonzales in Mandaluyong City from 9:00 am to 4:00 pm. SDO Mathematics Education Program Supervisors are also encouraged to attend.

Teachers shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003 entitled *Updated Guidelines on the Grant of Vacation Service Credits to Teachers*. On the other hand, non-teaching including the management staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on *Non-Monetary Remuneration for Overtime Service Rendered*.

Participants are advised to bring their own laptops. Training materials and meals will be provided for free while transportation shall be charged to local funds subject to usual accounting and auditing rules and regulations.
