

- 1. Pursuant to Memorandum OASOP No. 2023-A655 issued by Assistant Secretary Francis Cesar Bringas, designated National Technical Officials for the 2023 Palarong Pambansa from DepEd -NCR were granted and paid of meal allowance in the total amount of Eleven Thousand (PhP11,000.00) Pesos each, duly received by them on July 28-30, 2023 at Sto. Nino Elementary School, Marikina City.


