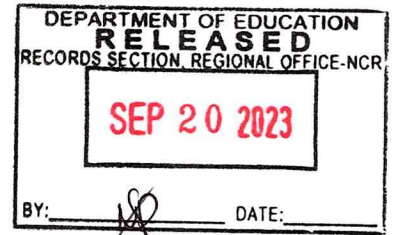

Neglected Tropical Diseases are a diverse group of communicable diseases that prevail in tropical and subtropical countries. The Department of Health - Metro Manila Center for Health Development (DOH-MMCHD) implements NTD programs in different LGUs and Hospitals in the National Capital Region (NCR) including the National Leprosy Control Program (NLCP), Food and Waterborne Prevention and Control Program (FWBDPCP) and Integrated Helminthiasis Control Program (IHCP).
