

As highlighted in the Republic Act No. 10533, known as the Basic Education Act of 2013, the State is mandated to create a functional basic education system that will develop productive citizens equipped with the essential competencies, skills, and values for tertiary education, middle-level skills development, employment, entrepreneurship, and lifelong learning.

Moreover, Rule V of the Implementing Rules and Regulations of the same Act states that the Department of Education (DepEd) is directed to properly guide secondary-level students in choosing career tracks that they intend to pursue by providing them with services/programs that will give information on career choices towards becoming productive and contributing individuals, through (a) integration of career concepts in the curriculum and relevant learning areas; (b) conduct of career assessments; (c) conduct of regular career advocacy activities; (d) conduct of continuous professionalization and capacity building for guidance counselors, career advocates, and peer facilitators; (e) development or accreditation of training programs on career advocacy; (f) establishment of career advocacy units and provide adequate office space in high schools; and (g) designation of guidance supervisors at the division level and career advocates at the school level.
