Highlighted in the Republic Act No. 10533 known as the Basic Education Act of 2013, is the State being mandated to create a functional basic education system that will develop productive citizens equipped with the essential competencies, skills, and values for tertiary education, middle-level skills development, employment, entrepreneurship, and lifelong learning.

Moreover, Rule V of the Implementing Rules and Regulations of the same Act states that the Department of Education (DepEd) is directed to properly guide secondary-level students in choosing career tracks that they intend to pursue by providing them with services/programs that will give information on career choices towards becoming productive and contributing individuals, through (a) integration of career concepts in the curriculum and relevant learning areas; (b) conduct of career assessments; (c) conduct of regular career advocacy activities; (d) conduct of continuous professionalization and capacity building for guidance counselors, career advocates, and peer facilitators; (e) development or accreditation of training programs on career advocacy; (f) establishment of career advocacy units and provide adequate office space in high schools; and (g) designation of guidance supervisors at the division level and career advocates at the school level.

In response, the Office of the Undersecretary for Operations (OUOPS), through the Office of the Assistant Secretary for Operations (OASOPS), and Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD), transitioning to Learner Formation Division, in collaboration with the Curriculum and Teaching-Bureau of Curriculum Development (CT-BCD), will spearhead the **2023 Career Guidance Program (CGP) National Kick-Off** on **September 25**, **2023** from **9:00 a.m.** to **12:00 p.m.** at **Tanghalang Rizal**, **Pasig City**.

This activity aims to employ knowledge and skills to implementers and focal persons of CGP; provide structure that classifies focal units, defining authorities, responsibilities, and accountabilities; and provide a foundation for the creation, revision, and finalization of CGP plans, programs, projects, and activities that will ensure opportunities for all learners to reach their full potential, to develop them holistically, and become productive citizens of the country.

In this light, we would like to respectfully request the presence of **Riki Iishi Wine Lopez**, Senior High School Student of Rizal High School, and President of the Supreme Student Government (SSG) of the said school to participate and serve as a panelist during the **Panel Discussion** of the said National CGP Kick-Off.

Further, the Regional Youth Formation Coordinator (RYFC) is hereby instructed to act as the designated guardian of the mentioned learner throughout the event. This includes, but is not limited to, confirming attendance and addressing any concerns the learner may have in coordination with BLSS-YFD and the organizing team.

To verify the learner's attendance, the RYFC shall send the signed Parental Consent and Waiver Form to the BLSS-LFD through email <a href="mailto:blss.lfd@deped.gov.ph">blss.lfd@deped.gov.ph</a> on or before Sept. 19, 2023, Tuesday.

Travel and other related expenses to be incurred in the said activity shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.

#### **Event Rationale**

Republic Act (RA) 10533, or the "Enhanced Basic Education Act of 2013," Sec. 2 declares that "The State shall create a functional basic education system that will develop productive and responsible citizens equipped with the essential competencies. skills. and values for both life-long learning employment." Aligned with Section 9 of the same Act, the Department of Education (DepEd), in coordination with other agencies shall pursue career advocacy activities. Additionally, in line with its Constitutional mandate, and outlined in Section 2 of RA 9258, known as the "Guidance and Counselling Act of 2004," the DepEd shall develop the capability of career counselors and advocates to guide the learners and equip them with the necessary life skills and values.

Recognizing the paramount importance of nurturing learners' holistic development, the Education Act of 1982, also referred to as *Batas Pambansa Bilang 232*, Section 9, underscores that every learner has the right to school guidance and counseling. This implies that the government has already recognized the needs of learners for guidance and counseling services in schools.

Thus, the DepEd adheres and responds to the overwhelming concerns that may affect the development of learners which include an encompassing broad spectrum of challenges, including but not limited to poverty, absence or lack of access to comprehensive health services (may it be physical, mental, or psychological), war or terrorism conflicts, environmental issues like global warming and migration, as well as matters pertaining to gender and development.

Furthermore, the Implementing Rules and Regulations (IRR) of RA 9258 states that there should be a provision for counseling, psychological testing, research, placement, referral, and group processes in a guidance program. To effectively address the needs of learners for proper guidance and counseling through education, the Comprehensive Guidance and Counseling Program (CGCP) was conceptualized. The CGCP is designed to provide quality guidance services for all types of learners through proactive, preventive, and responsive activities designed to support learners' development. Its goal is to provide a framework for the provision of appropriate services, programs, and activities geared towards the development and enhancement of all types of learners. Specifically, it aims to assist the learners in efforts to attain a meaningful and productive life.

In response, DepEd has shifted guidance and counseling from a position-focused model that delivers services for a specific population to a comprehensive model that delivers programs and services to all learners in schools. The said modification must be accompanied by a reconceptualization of guidance and counseling from an ancillary, crisis-oriented service model to a proactive, developmental, and comprehensive model that includes preventive and responsive activities designed to serve the diverse needs of learners.

As stipulated in RA 11036, or the Mental Health Act, Chapter V, Sections 23 and 24, integration of Mental Health in the Educational System shall be ensured. This entails a guaranteed age-appropriate content within the curriculum across all educational levels. Further, to strengthen the promotion of Mental Health Program in educational institutions such as schools, colleges, universities, and technical schools, the

development of policies and programs shall be prioritized for students, educators, and employees to raise awareness on mental health issues; identify and provide support and services including facility access especially for individuals at risk, provide referral mechanisms to individuals with mental health conditions for treatment and psychosocial support. All public and private educational institutions shall be required to have mental health professionals.

Considering all these, through the issued DepEd Order No. 22, s. 2023, or the Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024, a CGP Orientation is set to commence for Grades 9-12. As such, the Office of the Undersecretary for Operations (OUOPS), through the Office of the Assistant Secretary for Operations (OASOPS), and Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD), transitioning to BLSS-Learner Formation Division (BLSS-LED), in collaboration with the Curriculum and Teaching-Bureau of Curriculum Development (CT-BCD), shall conduct the 2023 Career Guidance Program National Kick-off on September 25, 2023 at Tanghalang Rizal, Pasig City.

This event will gather selected learners, youth leaders, and education stakeholders with diverse backgrounds from different elementary and secondary institutions within Metro Manila and nearby local communities/regions in a face-to-face arrangement that will allow the attendees the opportunity to learn not only from the key national and international speakers and activities but also by engaging with one another in understanding the CGP and other related issues and concerns.

### **Exclusion (Limitations/Ineligibility)**

I am aware that symptoms of COVID-19 include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, the new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea.

I confirm that my child currently has none of those symptoms, and is in good health. I will not allow my child to physically go to the event if my child or any member of my household develops any of the said symptoms or any other symptoms of illness that may or may not be related to COVID-19. I will also inform the school/division and not allow my child to attend the event if my child or any of my household members tests positive for COVID-19.
