- In support of the upskilling and reskilling of educators through professional development, the National Educators Academy of the Philippines (NEAP), in partnership with the Philippine Normal University (PNU), has been implementing the Linking Standards and Quality Practice (LiSQuP) program, a two-year post-graduate customized program for teachers and school leaders to aid in the upgrading of education quality. LiSQuP's primary goal is to ensure that teachers and school leaders are equipped and engaged in the achievement of the expectations of the Philippine Professional Standards for Teachers (DepEd Order No. 42, series of 2017). Philippine Professional Standards for School Heads (DepEd Order No. 024, series of 2020), and Philippine Professional Standards for Supervisors (DepEd Order No. 025, series of 2020). It is also anchored on DepEd Order No. 11, s 2019 which aims to make progress in upgrading education quality in the Philippines through the transformation of NEAP.
- Stipulated in the Scholarship Contract under DM 82, s. 2020, Guidelines on 2. the Registration of Teachers and School Leaders for NEAP-Recognized Professional Development Programs and Courses, a scholar shall refund in full to DepEd such sums of money as may have been defrayed by the Philippine government for expenses incidental to having attended the program or course, for failure to comply with any of the foregoing conditions through the scholar's fault or willful neglect, resignation from the service, transfer to other agencies, voluntary retirement or other causes within one's control. For reasons beyond the control of the scholar,

the conditions do not apply, provided that all documentary requirements including doctor's certification are met and are acceptable to DepEd.

3. LiSQuP is currently on its Academic Term 3.2 and NEAP no longer accepts withdrawals. However, the withdrawal requests and supporting documents of the following scholars, endorsed by NCR- Office of the Regional Director on September 11, 2023, were evaluated by NEAP:

- 5. Thus, the Office hereby approves these scholars' withdrawal requests. Their names shall be immediately removed from the roster of LiSQuP Cohort 1 Scholars. They shall also be cleared from their financial obligation to DepEd and from any responsibility as scholars of LiSQuP. Furthermore, PNU shall also be informed of the decision accordingly.
