All other provisions indicated in the enclosed Office Memorandum ROP No. 169, s. 2023 shall remain in effect.

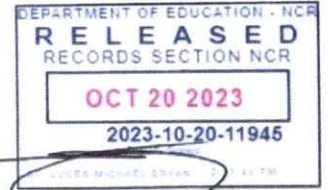
