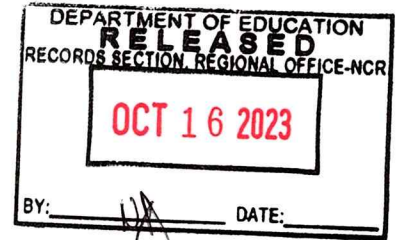

**LEARNER RIGHTS AND PROTECTION MEMORANDUM OF
AGREEMENT (MOA) SIGNING WITH PARTNERS AND
3RD QUARTER COORDINATION MEETING**

1. The Department of Education – National Capital Region through the Regional Learner Rights and Protection Section (Formerly Child Protection Unit) will hold a Memorandum of Agreement (MOA) signing with Learner Rights and Protection Partners and 3rd Quarter Coordination Meeting on October 24, 2023, to be held at Conference Hall, Regional Office, Department of Education -National Capital Region;
