





The Bureau of Learning Delivery – Teaching and Learning Division (BLD-TLD) conducted a series of online workshops on the Development and Revision of Lesson Exemplars on Human Rights Integration in Araling Panlipunan for Grades 1-10.

To continue with the development process, BLD-TLD will conduct a **Validation Workshop on Araling Panlipunan Lesson Exemplars with Human Rights Integration** to be held at **RELC-NEAP, Malvar, Batangas Province** on **October 24-27, 2023**.

The activity aims to:

- discuss concepts and ideas on human rights;
- impart pedagogical strategies on how to integrate human rights concepts and ideas; and
- develop lesson exemplars integrating these pedagogical strategies.
