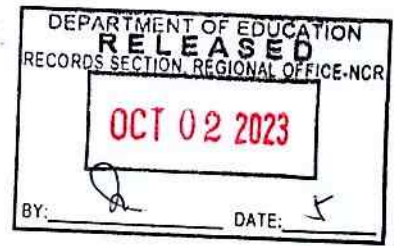

**REQUEST FOR COMMENTS AND REVIEW ON THE DRAFT OF DEPED REVISED PROGRAM ON AWARDS AND INCENTIVES FOR SERVICE EXCELLENCE (PRAISE) POLICY**
