



SYSTEM FOR PUBLIC SCHOOL TEACHERS"

DATE : 21 September 2023

On June 23, 2022, Executive Order (EO) No. 174, titled "*Establishing the Expanded Career Progression System for Public School Teachers*," was issued with the objective of promoting professional development and career advancement among public school teachers and defining the career lines of teachers within the public school system. Consequently, supplementary policies, standards, and guidelines need to be formulated to operationalize and implement the Expanded Career Progression (ECP) System for teachers within the public basic education system.

The Department of Education (DepEd), specifically through the Bureau of Human Resource and Organizational Development - Human Resource Development Division (BHROD-HRDD) in collaboration with the Department of Budget Management (DBM), took the initiative to develop the **DBM-DepEd Joint Circular** that outlines the *Modified Position Classification and Compensation Scheme for Teacher Career Progression in Public Elementary and Secondary Schools*. This Joint Circular seeks to revise Chapter 6 of the Position Classification and Compensation Manual (PCCM) issued under DBM Circular Letter No. 2007-6 to integrate the Philippine Professional Standards for Teachers (PPST)¹ and Philippine Professional Standards for School Heads (PPSSH)² as the main anchoring principle of career advancement, through reclassification of positions, along the ECP System. Likewise, it redefines the existing

ratio for Master Teacher positions to align with their evolved functions under the professional standards.

Furthermore, the **DepEd Order** has been drafted detailing the *Operational Guidelines on the Expanded Career Progression System and Reclassification of Teaching Positions*. This provides for the internal guidelines on the implementation of EO 174 in DepEd including its subsequent issuances; and set forth a systematic and competency-based process of reclassification of teaching positions anchored on the established professional standards.

These two (2) supplementary policies are currently slated for validation and finalization in collaboration with field personnel, officials, and key stakeholders with the aim to:

- a. validate and quality assure the draft DBM-DepEd Joint Circular and draft DepEd Order;
- b. discuss in depth the specific parts and provisions of the draft policy documents with incumbents of positions and key stakeholders;
- c. solicit comments and suggestions for incorporation into the draft policy documents; and
- d. draw agreements and finalize the draft revised DBM-DepEd Joint Circular and DepEd Order.
