**CHILD PROTECTION COMMITTEE (CPC) FUNCTIONALITY
TRAINING WORKSHOP**

1. Congruent with the MATATAG Agenda and the Learner Rights and Protection mandates that all learners shall be ensured of protection from violence, exploitation, discrimination, bullying, and other forms of abuse in schools where their right to quality and inclusive education is respected, protected, promoted, and fulfilled. Premise to the DepEd Memorandum OUOPS No. 2023-07-5183 dated May 15, 2023, relative to the "*Utilization of Program Support Funds for the Child Protection Committee (CPC) Functionality and Learner Rights and Protection Events*", this Office, through the Learner Rights and Protection Section shall implement of the above-captioned activity on November 13-17, 2023. The venue will be determined once the procurement process has been completed.
2. The conduct of seminar training for CPC functionality is aligned with the Special Provisions of Republic Act No. 11936 or the General Appropriations Acts for F.Y. 2023 for the Child Protection Programs, "to support the operations of the Department of Education, such as planning and strategizing, and program development in implementing the Child Protection Policy, among the child protection committees in the regions, divisions, and schools".
3. This 5-day training workshop intends to capacitate the Schools' Child Protection Committee with their functionality to ensure the implementation of the Child Protection Policy at the school level. The participants are the Regional and Division Learner Rights and Protection Focal Persons and LRP Alternates, two (2) Public School Principals (1 HS, 1 Elem.), two (2) Registered Guidance Counselors or Guidance Teachers (1 HS, 1 Elem.). 4. Program arrangements are as follows:

- The Opening Program shall commence on November 13, 2023 (Day 1) at 1:00 PM, with PM snacks as the first meal. The standard hour for the check-in of participants is between 1:00 PM – 5:00 PM;

- SDOs and School Heads are requested to carry out a flexible mechanism to ensure the continuity of their operations while attending the activity;
