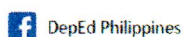
The Bureau of Curriculum Development, Special Curricular Programs Division gives notice on the change of dates for the Writeshops on the Development, Validation and Finalization of the Merged G7-10 Arabic Language (AL) and Islamic Values Education (IVE) Curriculum. (See Table below)

The adjustment in dates was made in order to allow extension period for the Bureau to thoroughly review the initial output obtained from the Development, Validation, and Finalization phases of the Merged K-3 and G4-6 Arabic Language and Islamic Values Education Curriculum. These two key stage levels represent the initial phases in the curriculum development process and were carried out between May and August 2023. Thus, it is imperative that the remaining ALIVE workshops, specifically in the merging of the Arabic Language and Islamic Values Education for the third key stage (G7-10) should follow next and should be implemented before the year ends.
