

The Department of Education (DepEd) reiterates the utilization of excess Program Support Funds (PSF), sourced from the 2023 Basic Education Curriculum (BEC) funds, and the 2023 General Management and Supervision-Maintenance and Other Operating Expenses (GMS-MOOE), to support National Learning Recovery Program (NLRP)-related activities until December 2024 adherent to the provisions set forth in the Joint Memorandum of the Office of the Undersecretary for Curriculum and Teaching (OUCT) and Office of the Undersecretary for Finance (OUF) dated July 3, 2023.

Relative thereto, the following additional provisions are hereby provided:

1. Regional Offices shall be responsible in approving requests from Schools Division Offices on the utilization of any excess National Learning Camp (NLC) PSF funds charged to the 2023 Basic Education Curriculum (BEC) funds; and
2. The excess funds of the NLC PSF charged to the 2023 General Management and Supervision-Maintenance and Other Operating Expenses (GMS-MOOE), shall only be used for the payment of meal expenses for the forthcoming NLC and other EOSY Break Activities for SY 2023-2024.
