PROGRAM MANAGEMENT INFORMATION SYSTEM (PMIS) TRAINING WORKSHOP FOR SELECTED PILOT SCHOOLS IN THE NATIONAL CAPITAL REGION

- 1. In support to the Department of Education's thrust to modernize education management and governance, the enhanced Program Management Information System (PMIS) is being implemented in the Central Office, Regional Offices, and Schools Division Offices. As a web-based information system, the PMIS was designed to improve the department's progress monitoring of the status of programs and projects implementation. It will also provide quality, relevant, and timely information that can be used for planning and budgeting, results monitoring and evaluation, and for policy decision making.
- 2. The PMIS was developed to support the Department's Planning and Budget Strategy. The system shall be the official source of data on programs, projects and activities (PPAs) of DepEd from planning to implementation,
- 3. It aims to:
 - support the effective and efficient management of plans and programs,
 - increase transparency of plans and programs at all levels of governance from DepEd Central Office to schools,
 - c. provide a platform that encourages a more diligent and systematic preparation of plans and utilization of budget,
