This memorandum is being issued to provide updates on the status of the Performance-Based Bonus (PBB) payout for Fiscal Year (FY) 2021 and updates on FY 2022 PBB.

1. UPDATES ON FY 2021 PBB PAYOUT

Based on Memorandum Circular (MC) No. 2021-1 dated June 3, 2021, or the *Guidelines on the Grant of the PBB for FY 2021 under Executive Order (EO) No. 80, s. 2012 and EO No. 201, s. 2016* and MC No. 2021-2 dated October 25, 2021, or the *Supplemental Guidelines on the Grant of the PBB for FY 2021 under EO No. 80, s. 2012 and EO No. 201, s. 2016*, the unit/s most responsible (including its head) for the Eligibility Criteria with a performance rating of below 4 will be isolated from the grant of the FY 2021 PBB. Likewise, the unit/s most responsible (including its head) for the non-compliance with the Agency Accountability will also be isolated from the grant of the PBB.

Under the Eligibility Criteria, the Department achieved a performance rating of 2 and 3 in its Performance Results and in its Client/Citizen Satisfaction Results, respectively. Moreover, the Department has non-compliances to three (3) Agency Accountabilities: 1) Submission of FY 2021 Annual Procurement Plan for Non-Common-Use Supplies and Equipment (APP Non-CSE); 2) Updating and posting of

PhilGEPS; and 3) Undertaking of early procurement for at least 50% of goods and services covering FY 2022 programs and projects.

Considering all these, here is the list of the isolated individuals and their positions during the FY 2021 deadlines which will be isolated from the FY 2021 PBB pay-out:

2. FY 2022 UPDATES

Based on the initial list of National Government Agencies with Deficiencies to Agency Accountability Requirements for FY 2022 PBB (*update as of April 12, 2023 posted in the DAP RBPMS*), DepEd has non-compliances to two (2) Agency Accountabilities namely: PhilGEPS Posting and the FY 2022 APP Non-CSE. There are 69 offices/units that are non-compliant to PhilGEPS Posting while 162 offices/units are non-compliant to FY 2022 APP Non-CSE (*see Annex C*).

For those non-compliant units who wish to appeal their status on FY 2022 APP Non-CSE, you must submit a **screenshot of your e-mail thread with GPPB-TSO** (the validating agency for said agency accountability) to the DepEd PBB Secretariat via e-mail at pbb.monitoring@deped.gov.ph. The screenshot of e-mail thread must show the following requirements:

- 1) FY 2022 APP non-CSE was submitted on or before 31 March 2022 to GPPB through e-mail at app@gppb.gov.ph where PDF and Microsoft Excel files of the APP are seen attached in the e-mail thread;
- 2) Posting Certification was also submitted to GPPB, either as an added attachment in the initial submission to GPPB or subsequent submission provided that said document was submitted on or before the set deadline; and,
- 3) Acknowledgement email from GPPB was received by the office, which should also be seen in the e-mail thread.
