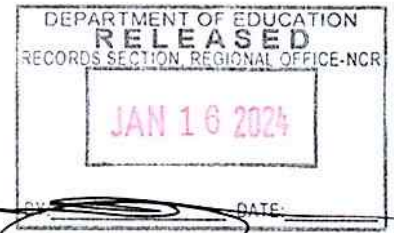

This is in reference to DepEd Order No. 22, s. 2023 on the *Implementing Guidelines on the School Calendar and Activities for the School Year 2023-2024* and DepEd Memorandum No. 43, s. 2023 on the *Guidance on the Conduct of Enrollment for School Year 2023-2024*. As stipulated in the said issuances, all public and private elementary and secondary schools, including SUCs/LUCs offering basic education, and **community learning centers (CLCs) shall update or encode the learner's profile in the Learner Information System (LIS).**

In line with this, all Regional and Division Alternative Learning System (ALS) Focal Persons and Education Program Specialists II for ALS (EPS II for ALS) are requested to monitor and fast track the **encoding of enrolment of learners of ALS Implementors (ALS Teachers, Community ALS Implementors, and Learning Facilitators) in the LIS** to establish accurate and updated ALS enrollment data before the initial LIS closure scheduled this January 2024.
