The Disaster Risk Reduction and Management Service (DRRMS) issues this advisory for the "2023 National Climate Change Conference (NCCC) and the 2023 National Disaster Risk Reduction and Management (DRRM) Year-End Evaluation and Planning (NDYEP) Workshop". - a. RISK REDUCTION AND MANAGEMENT SERVICE (DRRMS) SCHEDULED ACTIVITIES DUE TO IMPENDING HAZARD

In reference to the memorandum **OUOPS No. 2023-04-10050** titled Conduct of the 2023 National Climate Change Conference (NCCC) and the 2023 National DRRM Year-end Evaluation and Planning (NDYEP) Workshop dated October 26, 2023 and **OUOPS No. 2023-04-09781** titled Invitation to the Workshop on the Enhancement of Safe Learning Environment and Facilities (Pillar 1) Guidebook dated October 19, 2023, the Disaster Risk Reduction and Management Service (DRRMS) issues this advisory to inform all confirmed participants of the adjustments to these activities initially scheduled this month.

The DRRMS is monitoring the Low-Pressure Area (LPA) located at 1,620 km. East of Southeastern Mindanao that is possible to re-develop into a tropical cyclone, based on the latest advisory issued by the DOST-PAGASA on November 14, 2023, 5:00 AM. According to the weather advisory, the LPA is forecast to accelerate towards the west or west-northwestward. It may enter the Philippine Area of Responsibility (PAR) region later today or early tomorrow.

Considering the abovementioned circumstances that might expose participants at risk, the DRRMS hereby postpones the following activities and reschedules to the dates specified below:
