Now on its 45th edition, the 2024 MILO® Marathon will be running the qualifying races in fifteen (15) cities nationwide. There will be six (6) categories (i.e. 1K, 3K, 5K Fun Run, 5K Champion Family, 10K, and 21K) for the regional races and seven (7) categories (i.e. 1K, 3K, 5K Fun Run, 5K Champion Family, 10K, 21K, and 42K) for Manila.
