

Greetings from BEA!

In adherence to DepEd Order No. 29, s. 2017, "Policy Guidelines on System Assessment in the K to 12 Basic Education Program," the Philippines will participate for the third time in the Programme for International Student Assessment (PISA). This Bureau, through the Education Research Division, serves as the PISA National Center of the Philippines and leads the administration of the PISA 2025 test cycle.

Background Information on PISA

PISA is an international study designed and developed by the Organisation for Economic Co-operation and Development (OECD). The goal of PISA is to evaluate education systems worldwide by testing the skills and knowledge of 15-year-old students, who are approaching the end of their compulsory education. PISA tests how students can apply their knowledge to real life situations and problems, rather than testing their knowledge recall. Every three years, participating countries assess their 15-year-olds in the three cognitive domains: Reading, Mathematics, and Science; and in PISA 2025, Science is the major domain.

Like most participating countries and economies, PISA in the Philippines shall be administered through a Computer-Based Assessment (CBA) scheme. This unique feature provides an interesting testing approach whereby students will be navigating a variety of interactive test scenarios using computers.

PISA 2025 Field Trial

The PISA 2025 field trial is primarily conducted to gather evidence on the psychometric properties of the new items of PISA and to test survey operation procedures in preparation for the Main Survey. The PISA 2025 Field Trial will be conducted from 1 April to 26 April 2024 in 31 sample schools nationwide; the specific

schedule for each school shall be issued on a separate advisory. Further, a total of 89 students shall be randomly selected per school.
